In exercise of the powers conferred on it by Sections 33 and 39 of the Constitution of Sierra Leone, 1991 (Act No. 6 of 1991) and Sections 69(1), 70(1) and 98 of the Public Elections Act, 2012 (Act No. 4 of 2012) and Sections 4 and 28 of the Chieftaincy Act, 2009 (Act No. 10 of 2009), the Electoral Commission for Sierra Leone (ECSL) makes the following proclamation:

**Saturday 20th April, 2024** is hereby declared as the day for the conduct of a Paramount Chief Member of Parliament bye-elections in Kenema and Pujehun Districts.

The vacancy occurred as a result of the death of **Honourable PC Foday Steven Kpakra-Faba of Dodo Chiefdom, Kenema District and Honourable PC Boima Victor Sidee Kebbie III of Malen Chiefdom, Pujehun District, on Monday 23rd October 2023 and Sunday 14th August 2023 respectively.**

Nominations of Candidates for the said Paramount Chief Member of Parliament (PCMP) bye-elections shall take place on **Wednesday 20th and Thursday 21st March, 2024 at the respective ECSL's District Offices at: 2 Kambowabu Street, Kenema District; and 8 Sesay Street Pujehun District.**

Each registered voter intending to present endorsed candidates for the Paramount Chief Member of Parliament bye-elections to be held on **Saturday 20th day of April, 2024 in Kenema and Pujehun District**, shall submit to the Electoral Commission for Sierra Leone a list of endorsed candidates for nomination for the above mentioned bye-elections not later than 3:00 pm on **Friday 15th March, 2024**. - 4 The District/Locality in which he/she will stand for election.

Candidates shall select a symbol from a list of symbols provided by the Electoral Commission for Sierra Leone.

Approved candidates will then proceed through the nomination process scheduled to take place on **Wednesday 20th and Thursday 21st April, 2024** at the respective **ECSL District Elections Office: ECSL District Offices at: 2 Kambowabu Street, Kenema District; and 8 Sesay Street Pujehun District**.

Guidelines on the nomination of candidates will be issued in due course by the Electoral Commission for Sierra Leone.

**(2) Qualifications**

In addition to being registered as voters, candidates must satisfy the other qualifications contained in Sections 75 and 76 of the Constitution of Sierra Leone, 1991 (Act No. 6 of 1991) and Sections 97 and 98 of the Public Elections Act, 2022 (Act No. 17 of 2022), in order to qualify for nomination.
