THE PLANT PHYTOSANITARY (IMPORT RESTRICTION) NOTICE, 1976

In exercise of the powers vested in me by Rule 9 of the Plant Phytosanitary Import Rules, 1974, I hereby declare, with the approval of the Minister of Agriculture and Natural Resources, that the conditions for the importation of the plants listed in the Schedule shall be as set out in this Notice.

Any person found practising as a Nurse or Midwife and not registered with the above-named Board shall be guilty of an offence and shall be liable on summary conviction to a fine not exceeding one hundred leones or to imprisonment with or without Hard Labour for a period not exceeding six months or to both fine and imprisonment.

CONSUMER PRICE INDEX FOR MINEWORKERS—4TH QUARTER, 1975

The Consumer Price Index for Mineworkers for 4th quarter, 1975 was 183.5 as compared to 184.4 for 3rd quarter, 1975. This shows a decrease of 0.9 points or about 0.49 per cent over the previous period.

Almost in line with the 4th quarter, 1975 Consumer Price Index for Freetown, the most important decrease among the major group item was for "Food and Drinks" while an appreciable increase was noted for "Housing". The index (1961=100) measures the average change in prices of a fixed list of goods and services known as "Market Basket" which represents the purchases of the low income African families in the Mining Areas of Marampa, Yengema and Tongo Field. Separate indices are computed for Marampa and the Diamond Mining Areas (Yengema and Tongo Field combined). These are combined into a single index weighted in proportion to the number of workers employed in each area.

Food and Drinks:—The index for this group dropped by 10.3 points or 4.6 per cent over the previous quarter consequent to considerable drop in the average prices of dried bonga, dried snapper, fresh fish, oranges, onions and pounded groundnut coupled with moderate drop in the average prices of rice and coffee. This drop was however offset by a huge increase in the average prices of small pepper and tinned tomato puree and moderate increase in the average prices of jacato, beef (steak) and palm oil.

Housing:—The housing index rose by 12.9 points or 7.5 per cent over the previous quarter as a result of an increase in the average prices of firewood and kerosene.

Clothing:—A substantial increase of 4.9 points or 3.3 per cent was recorded due to some increases in the average prices of men's singlet, drill materials and tailor charges for sewing men's garments (shorts). There was however a small drop in the average prices of headties lappas, ladies dresses and children's wear.

Miscellaneous:—An overall drop of 2.3 points or 1.6 per cent was noted consequent to a decrease in the average prices of tobacco leaves and kola nuts. A small increase in the average prices of soda soap was however noted

CONSUMER PRICE INDEX, FREETOWN—4TH QUARTER, 1975

The revised Freetown Consumer Price Index for the 4th quarter of 1975 was 208.0 as compared to 212.7 in the 3rd quarter 1975. This shows a drop of 4.7 points or 2.2 per cent over the previous quarter

The most important drop among the major group items was for "Food and Drinks" which dropped by 8.5 per cent over the previous period. The index (1961=100) indicates the average movement of retail prices of selected item known as "market basket" which represent the purposes of the low income African families in Freetown.

Food and Drinks: A substantial drop of 21.1 points was noted mainly accounted for overall relative price declines in the average prices of dried snapper, fresh fish, rice, onions, pounded groundnut and beef (steak). These drops were however partially offset by increases in the average prices of dired bonga, big and small peppers, potatoe leaves, fresh tomatoes, coffee, groundnut oil, oranges, mangoes and bananas. The last 3 items were not in season and this might be responsible for their relative price increases.

Housing: The housing index rose by 8.8 points or 4.9 per cent over the previous quarter. This increase was due to rise in the average prices of putty, chairs, mattresses, drinking glasses and galvanised kettle (bucket). These rises were probably due to the period of the year in question.

Clothing: Like the housing index, clothing index rose substantially by 25.1 points or 19 per cent. The increases were attributed to a rise in the average prices of shirting, cotton prints, ladies nylon slips, ladies plastic sandals, men's cotton singlets, cotton drill, poplin broadcloth, cotton print and tailor charges for men's and ladies garments.

Miscellaneous: The index for this group rose highly by 27.4 points or 18.8 per cent consequent to substantial increases in the average prices of bus fares and religious dues.

3. *Background*

International Programme on Environmental Education and Training of Engineers and Allied Professionals.

This is a global project jointly financed by UNESCO and UNEP, under its Environment Fund. The project includes pilot schemes in different countries which use as a basis national projects in the field of engineering education which UNESCO executes under the United Nations Development Programme (UNDP).

The United Nations Conference on the Human Environment clearly recognized the need for:

- (a) adaptation of the training for members of professions involved in environmental planning and particularly the training for those who act directly upon the environment such as engineers, architects, town and physical planners;
- (b) and therefore for introducing into the existing curricula of training for these professions a set of general notions together with advanced training in the environmental management techniques associated with each of the professions concerned.

The project, in promoting the development of the environmental component of the education and training of engineers, represents a direct contribution to the fulfilment of the above objectives and furthermore to the basic of a goal of the education and training area of the UNEP programme, as approved by the Governing Council at its third session, namely:

The creation and enhancement of indigenous capabilities and capacities required to enable countries to identify and deal with the environmental aspects of their development, and more specifically:

- (a) to effect a rapid and systematic development of environmental education on a global basis; to provide training in specific areas of policy, programming and implementation of national and regional development plans based on properly developed methods including environmental dimensions;
- (b) to create environmental awareness at the highest policy levels and hence at the levels of decision making in all sectors of development, in both the public and the private context, will be major objectives;
- (c) to provide the education and training necessary to make it possible for all countries to be able to participate in all appropriate parts of the rest of the programme in an informed manner as equal partners;
- (d) to establish means of inducing policy-makers, decision-makers and administrators in the Governments of all countries to include environmental dimensions in the consideration of their policies, programmes and projects.

Considering the influence of a diversity of categories of engineers in the shaping of future environment and in the solution of present environmental problems, the project aims ultimately to ensure that environmental considerations are taken into account in all types of technological projects, especially as regards the economy of energy and other resources, the development of adequate human habitat on a global scale, the creation, use and dissemination of environmentally sound technologies.

Following the recommendation of the UNESCO/UNEP international Meeting of Experts on Environmental Aspects of Engineering Education and Training (Unesco House, Paris, 17-21 June 1974) the project will be directed to consolidate and expand joint activities of UNEP and UNESCO for the development of environmental aspects of engineering education and training, within the Organization's programme for the reform and modernization of engineering education in response to the needs of society.

4. Functions

Under the supervision of the Director of the Division of Technological Research and Higher Education, the incumbent will act as the Head of a team of advisers and consultants that will be in charge of advising and assisting Member States and UNESCO Secretariat in the implementation of an International Programme on Environmental Education of Engineers and Allied professionals, jointly sponsored by UNESCO and the United Nations Environmental Programme (UNEP).

In particular the incumbent will be responsible for:

- (a) formulating, in co-operation with the project officer, detailed work plans for the implementation of the different components of the International Programme and co-ordinating all field activities involved;
- (b) carrying out technical negotiations with institutions participating in the international programme and organizing pilot educational schemes as well as training programmes for practising engineers;
- (c) participating in the delivery of courses of instruction for engineering students at the undergraduate and post-graduate levels as well as in the delivery of training programmes for practising engineers;
- (d) developing and maintaining appropriate co-operation and liaison with Unesco's Regional Offices of Science and Technology (in Cairo, Nairobi, Jakarta and Montevideo) as well as with UNEP Headquarters for the implementation of the International Programme;
- (e) assisting and advising UNESCO Secretariat and relevant national institutions in connection with sub-contracts for the production of educational resources and the publication of an international newsletter;

- (f) maintaining contacts with national, regional and international professional organizations relevant to the implementation of the International Programme.

5. Qualifications

- (a) Professional degree in either chemical, Mechanical, Civil or Electrical Engineering with doctorate degree in environment area such as environmental engineering, ecology, environmental management. This doctorate degree must emphasize environmental systems analysis, economics, policy and legislation;
- (b) experience in the development of inter-disciplinary curricula and courses of study of the environmental education of engineers of all branches;
- (c) experience in the organization of continuing education programmes in the field of environment for practising engineers;
- (d) high level experience in engineering education, as well as in research and industrial consultancy, including participation in environmental planning as well as in the solution of environmental problems.
